2020 Lake Treatment

Our Lake treatment is scheduled for the week of June 22, 2020. We received a Grant of \$15,000.00; these extra funds gave us 2.5 more acres we could treat with herbicide. We received our permit from the DEC on May 6th. A-Tip Control, Inc. will be the company applying the treatment as they did such a wonderful job last year. The restrictions for consumption and swimming will be the day of the treatment. Irrigation will be for 5 days.

Hexavalent Chromium

After the sediment testing the DEC required for the permit application, prior to granting the permit for Hydro-raking Shingle Mill Creek it was determined that a higher level than accepted by the DEC of Hexavalent Chromium was found in the sediment of the Creek. Hexavalent Chromium also known as Chromium 6 was used by Tanneries and many industries. Many residences had their wells tested after being informed about the Chromium 6; the results came back with less than harmful levels of Chromium 6. The levels are established by the DEC for well water. Our main concern was to find the origin of the Chromium. The fact that Chromium 6 was found in our sampling could be caused from a myriad of sources.

After months of calls to the DEC for direction on how to handle the issue with Chromium 6 we felt we were going nowhere. Mark had told them at each call, "we weren't going away". The DEC has denied our Hydro-raking permit for an incomplete application. They are requiring additional tests to determine if the sediment could be removed without spreading the Chromium 6. Mark has been in contact with the department of the DEC that handles "Super Funds"; they too have requested more sediment testing. We would have to meet certain criteria to receive funding for a clean-up. Our Association would never have enough funds to cover the removal of the Chromium from the Creek. As you know, Plumley Engineers were hired to do the previous sediment testing. They offered us the equipment to do the testing ourselves to save us money. They also gave us a contact person in the lab that does their testing and we were given Plumley's discount. Mark and I with the help of the Bob Thompson on May 12th took 6 more samples. We took 2 from the upper Creek, 2 from the lower Creek, 1 from First Lake and 1 from Fourth Lake. We wanted to compare the lake results to the Creek results. Pending the results of this latest sediment sampling we will decide the best avenue to move forward.
